Lodging financial assistance

Criteria

Low-income is defined as meeting Medicaid eligible income levels.

Reservations must be made by Shodair's treatment team only.

Reimbursable overnight stays must be pre-approved by Shodair staff 24 hours before.

Family/Guardian must travel more than 150 miles one-way to qualify for provided lodging.

Discount rates available at the following hotels:

Super 8, Baymont Inn, Shilo Inn, Radisson, Howard Johnson, La Quinta, Days Inn, and the Fairfield Inn.

A therapy session must be scheduled as part of the assistance criteria.

Visits due to patient discharge requires a therapeutic session.

Details

As part of addressing a community need, Shodair will cover room accommodations for a maximum of three consecutive nights for any single trip.

• This does not include

- Added phone charges.
- Room service for food, etc.
- Pay-per-view movies, etc.
- Any damages to facility accumulated by the visiting family.
- Families who bring pets.



Meals

If family/guardian stay at one of the Shodair approved lodging sites breakfast is provided as part of the motel's package of services.

Shodair has snack packs available free of charge, just ask!

Other meals for the patient may be reimbursable from the state's Medicaid Transportation program if they meet the following criteria:

- Meals are on the day of the visit.
- Meals are only reimbursable for one.
- Limit is \$5.50 per a meal.
- Receipts must be provided.
