# Shodair Children's Hospital Community Health Improvement Plan FY2020-22

In April of 2019, Shodair Children's Hospital completed its every three year Community Health Needs Assessment. This Assessment identified four key areas of mental health needs within its primary service area.

One of these needs, specifically the lack of mental health providers in both rural and urban communities, has been addressed in Shodair's 2019 Strategic Plan. The other three needs listed below were selected by Shodair leadership as areas to focus its community health improvement efforts over the next three years.

- EDUCATION TO RURAL COMMUNITIES
- LOW INCOME NEIGHBORHOODS
- NATIVE AMERICAN POPULATION

## **Priority Area 1 EDUCATION TO RURAL COMMUNITIES**

## **Priority Area 1.1 Education of Schools**

<b>Overall Goal</b>	To ensure educators of schools in rural communities of MT
	are well informed of youth mental health issues and
	supportive strategies with students

#### Year 1:

- To create a resource document as a reference for educators
- Invite local and surrounding educators to relevant Shodair in-house training sessions

#### Year 1-3:

- To provide presentations to Educators at state and regional gatherings
- To implement a quarterly e-newsletter to Educators:
  - What's new at Shodair
  - Focused topics of value to educators
  - Success story of student's transition from Shodair back to school
- Provide consultative services to educators as requested

# Priority Area 1.2 Education of Referring Rural Hospitals and Community Providers

Overall Goal	To increase the knowledge and awareness of hospital and community providers working with children and youth as to the causes, diagnosis, treatment and mitigating strategies of children's mental illness
	(ACEs, YMHFA, Weighted Blankets, etc)

#### Year 1:

- Develop education materials in various media formats specific for presentations to rural hospital staff
- Follow up with thank you notes for patient referrals
- Conduct 2 on-site presentations to hospital staff
- Implement a quarterly e-newsletter to Hospitals:
  - What's new at Shodair
  - Focused topics of value to hospital staff
  - Spotlight a hospital and ambulance for recognition

#### *Year 2-3:*

• Conduct 3-5 on-site presentations to hospital staff

## **Priority Area 1.3 Education of Community Business Leaders**

Overall Goal	To increase the knowledge and awareness of the impacts of Adverse Childhood Experiences on the employees in their businesses and community and mitigating strategies

#### Year 1:

- Develop education materials in various media formats specific for presentations to rural community business leaders
- Conduct 2 on-site community presentations to business leaders in coordination with Shodair staff presenting at community hospital
- To participate and support the local Elevate Montana in its efforts to educate local business leaders
  - Provide Shodair person as member of Elevate MT team and workgroups
  - Provide financial support via Community Benefit Funds

#### Year 2:

• Conduct 3-5 on-site community presentations to business leaders in coordination with other Shodair staff presentations

- Invite the various stakeholders identified in 2.1 above to an initial meeting to communicate the purpose and expectations of this collaboration and to introduce them to the idea of "collective impact"
- Identify during this meeting other stakeholders that need to be included
- Create a calendar for regular workgroup meetings
- Develop and present education on ACEs, SDOH, etc. to ensure all workgroup members have a common understanding and language

- Establish subgroup assignments and due dates
- Combine the results of each subgroup into a Master Action Plan
- Develop funding needs to carry out action plan
- Discuss and agree on organizational structure for implementing the Master Action Plan going forward:
  - Existing organization or agency?
  - Continue with volunteers?
  - Form a new non-profit organization?
  - Other?

#### Year 2-3:

- Identify key measures of success
- Implement Master Action Plan
- Monitor success measures on a regular basis
- Incorporate new knowledge, technology, etc as it becomes available
